• Commissions and Task Forces are research bodies of the IGU that cover a very wide range of research topics within the discipline of Geography.

• The Commissions and Task Forces differ essentially because the Commissions carry out investigations on an extended subject area, while the Task Forces are established to pursue a specific objective, which may be concerned with research, education or other purposes.

•The IGU Statutes includes a whole section (paragraph VI) which is concerned with the Commissions. These are the key points:

Paragraph VI, A

Background goals — Commissions shall be established for the study of a specific problem or for the accomplishment of a task which requires international collaboration.

Paragraph VI, A

The mission — Commissions shall promote individual and group research work, encourage the exchange of relevant documents and information, and organize conferences, meetings and, where appropriate, field excursions, both between Congresses and during International Geographical Congresses.

Paragraph VI, B

The establishment proposal and approval— The establishment of a new Commission may be proposed by a member country or by the Executive Committee. It shall be discussed by the General Assembly and may be approved by the Executive Committee

Paragraph VI, D and J

 Commissions composition — A Commission shall consist of a Chair and a Steering Committee normally consisting of not more than ten other members [among them, Commissions may designate a Vicepresident and a Secretary-Treasurer].

The Steering Committee members shall serve for approximately four years and be eligible for reappointment for a second term of similar length [...] The Chair shall normally be appointed by the General Assembly; the list of steering committee members shall be approved by the Executive Committee.

 The maximum term of service on a Commission for a chair or steering committee member in any capacity shall be twelve years. Normally, there shall not be more than one member from any one adhering country.

Paragraph VI, F

Ordinary funding

Commissions may apply to the Executive Committee for grants of funds to enable them to carry out their work. [Currently, IGU Commissions annual operating grants are of 1000 U.S. dollars]

2. IGU COMMISSIONS' ACTIVITIES AND REPORTS

• Commissions activities basically include scientific meetings (within or outside the IGU congresses and conferences), publications, and cooperation efforts with other scientific bodies an institutions at national and international levels

•According to IGU Statutes (paragraph VI, I), each Commission shall prepare a concise report on its work which should be submitted to the Secretary General for the Executive Committee (EC) at least nine months before the next ordinary meeting of the General Assembly.

➤The report should include an account of the work carried out, the methods used, and the results obtained together, when appropriate, with a program of further research

➢ In addition to this quadrennial report, Commissions are requested by the EC to submit an annual report in the period between the General Assemblies

Commissions are renewable by the General Assembly on the recommendation of the EC and depending on evidence of activity and continued relevance to the objectives of the Union (Statutes, Paragraph VI: C and I).

3. THE IGU & IUHPST COMMISSION ON THE HISTORY OF GEOGRAPHY: AN OVERVIEW

- Created in the 21st International Geographical Congress (New Delhi, 1968), as *IGU Commission on the History of Geographical Thought Commission sur l'histoire de la pensée géographique*. Current title (*Commission on the History of Geography Commission sur l'histoire de la géographie*) adopted in the 31st International Geographical Congress (Tunis, August 2008).
- Since 1976, also acts as international Commission within the Division of History of Science and Technology (DHST) of the International Union of the History and Philosophy of Science and Technology (IUHPST).

 The Commission on the History of Geography aims to be a forum for promoting and exchanging ideas and outcomes on both the history of the field and, more widely, the history of geographical knowledge, experiences and practices, and their consequences and usefulness for understanding the contemporary world, providing IGU and IUHPS as a whole with a reflective view on the practice and meanings of geography

 Through its 46 years existence, the Commission has carried out a prolonged active work within both the IGU and the IUHPS, reflected, for example, in the almost 50 scientific meetings held and the publication of nearly 45 books (including the 33 GBS volumes edited up to present and some proceedings, monographs and journal special issues).

Work plan and main actions envisaged for 2012-2016 (I)

1) To encourage reflection, discussion and the mutual sharing of ideas and results about the different traditions and historiographical trends existing at international level.

2) To promote a better contextual understanding of the relationship between geography and society, within and beyond the academy.

3) To deepen our understanding of the utility of geography as a "reservoir" of ideas and experiences with which to address some relevant social and environmental challenges of the contemporary world.

4) To help to build a history of geography that takes fully into account contributions from beyond the European and Anglo-American regions.

Work plan and main actions envisaged for 2012-2016 (II)

5) To provide scholars, at an international level, with the resources and information necessary to conduct high quality research on the history of geography.

a) Creating an international directory of groups and associations concerned with the history of geography;

b) Creating an international directory of archives (both personal and institutional) related to the history of geography;

c) Introducing some changes in the *GBS* series in order to improve its spread and reach among the international community of geographers and historians;

d) Creating an online archive of biographical interviews to geographers, on the basis of the materials collected within the framework of the *International Dialogue Project* (1978-1988, A. Buttimer & T. Hagerstrand).
